

DFAT Support to the WG

Since 2016 DFAT has generously provided funds to support the activities of the Washington Group on Disability Statistics.

UCL has provided Administrative Support for the grant during the initial grant period 2016-2019.

DFAT Support to the WG

Broadly, activities covered by the grant include:

- Redesigning the WG a website
- Facilitating and supporting the provision of targeted training to national statistical offices, NGOs and DPOs.
- Supporting the dissemination of WG materials including presentations at over 16 international forums, such as the World Data Forum in Cape Town and Dubai, Global Disability Summits in London and Buenos Aires, and many relevant UN meetings.


DFAT Support to the WG

Broadly, activities covered by the grant include:

- The project has supported the WG in the generation of numerous publications, blogs and presentations.
- Supporting an active technical response capability through the WG website or directly through the Secretariat's e-mail account, thereby allowing the WG to routinely respond to requests for technical support within 24-48 hours through email, Skype or phone.

The WG: Shifting Focus

Since its first meeting in 2002 the WG has maintained a global perspective - addressing the need for population-based measures of disability in order to

- foster international cooperation and build a global consensus on disability measurement and
- produce measures that are internationally tested and will reliably produce cross-nationally comparable disability statistics.

A core goal has been to mainstream disability statistics and ensure that they become an integral element in national statistical systems.

The WG: Shifting Focus

During the past 4 years, with DFAT support, the WG has been able to continue its international work and has, in addition, begun to shift focus from providing *national* support, to building capacity *regionally*.





Regional centers

- Pacific Disability Statistics Working Group: representing island countries in the South Pacific
- Casablanca Group: representing the ESCWA region and Arabic-speaking countries of Northern Africa and the Middle East
- Brazzaville Group: representing countries in French-speaking and Western/Central Africa
- South Africa Group: representing countries in sub-Saharan Africa region
- Moscow Group: representing Russian-speaking countries in the CIS region
- Kathmandu Group: representing countries in the South Asian region

Regional Centers

During the current DFAT grant period, one Regional Center will be piloted to demonstrate how an on-going regional consortium of NSOs, working in consultation with civil society and advocacy groups, can be established as a viable and sustainable support mechanism for the on-going and accurate use of the WG methodology. The Asia-Pacific region was chosen as the pilot region.

Additionally, a meeting of all potential regional Center Directors is planned.

Regional Centers: Initial Workplan

This would include:

- securing membership from member countries in the region,
- developing scope of work and Terms of Reference,
- organizing meetings as needed and
- working with member countries through NSOs, civil society, researchers and advocates to meet their needs, and to ensure careful monitoring and evaluation of the pilot process to inform the establishment of future centers.

The project will continue to support:

- trainings (national, NSO/DPO/NGO),
- website development,
- consultations and
- technical response teams.
