

Thirteenth Meeting of the Washington Group on Disability Statistics

October 29-30, 2013: Amman, Jordan.

Overview

The 13th meeting of the Washington Group on Disability Statistics (WG) was held 29-31 October 2013 in Amman, Jordan. The primary focus of the meeting was a presentation from the workgroup on child functioning and disability on the development of a proposed question module designed to measure functioning and disability among children.

Results from additional analysis of country experiences measuring disability using the WG Short Set (SS) of questions and preliminary guidelines for analyses of the Extended Set of questions on Functioning (ES-F) using data from the US National Health Interview Survey (NHIS) were also presented.

In addition to reports on other Washington Group related activities, updates were provided on behalf of partner organizations with respect to their recent activities related to disability statistics, and the Steering Committee chair led a discussion on strategic issues including planning next steps.

Session 4: Methodological Issues Concerning Surveys – Child Disability

A review and presentation of additional work on the Module on Child Functioning and Disability (ES-C) were provided during this session; followed by an update on the cognitive testing of the question module and a discussion of plans for field testing including preliminary results from analysis of field test data. The session also included a review of UNICEF's work on measuring facilitators and barriers to school participation. The session concluded with a discussion of the next steps for the workgroup on child disability.
